Tournaments, 2026-27**

1. Allotment of dates-

Dates are allotted by PDTTA depending upon the State and TTFI calendar. In case of any changes, PDTTA reserves the right to change the dates.

2. Who can participate

The Registered Players from Pune District only will be eligible to play in PDTTA District ranking /Championship Tournament.

In Case of the Players from other districts who are desirous of participating in PDTTA District Ranking / Championship Tournaments, the decision of Managing Committee will be final & binding.

3. Age Groups for: Year 2026-27

Youth U-11 Boys & Girls who are born on or after **01.01.2016**

Youth U-13 Boys & Girls who are born on or after **01.01.2014**

Youth U-15 Boys & Girls who are born on or after **01.01.2012**

Youth U-17 Boys & Girls who are born on or after **01.01.2010**

Youth U-19 Boys & Girls who are born on or after **01.01.2008**

Veterans 40+ event – who are born on or before **01.01.1986**

Veterans 60+ event - who are born on or before **01.01.1966**

4. Age Proof

The player shall compulsorily produce **Age Proof & Aadhar Card** in case of U-11, U-13, U-15, U-17, and U-19 events and also for 40+ and 60+, if demanded.

5. Submission of Entries

- The entries are accepted only by email to mail.pdtta@gmail.com/entries.tt@gmail.com.
- Entry fees, to be paid before giving the entry, are to be paid on-line only. A circular issued before the tournament gives QR code and RTGS payment details.
- Player has to first pay the entry fee online and then send the email giving event wise entries along with the screen shot of the payment made.
- Entries are not accepted without entry fees.

If a seeded player gives a walkover without any valid reason, appropriate action will be taken.

6. Entry Fee details (District Ranking Tournament)

- Singles: Rs. 400/- per entry.
- Doubles: Rs. 600/- per entry.
- Entry fees once paid, will not be refunded in any case.

7. Registration Fee

PDTTA registration fee shall be Rs.200/- per player per year.

8. PLAYING FORMAT:

- a) The Tournaments will be played according to the current laws, Rules and Regulations of PDTTA
- b) Matches of Veterans, and all events under 17 age group will be best-of-five games throughout, including Finals.
- c) Matches of Boys & Girls under 19, will be best-of-Five games up to and including Semi Finals.
Only the Finals will be best-of-seven games.
- d) Matches of Seniors - (Men and Women) - will be best-of-five games up to and including quarter-finals. The Semi-finals and the Finals will be best-of-seven games.
- e) All doubles events shall be of best-of-five games throughout including Finals.
- f) TTFI approved balls will be used for the tournament.

9. Draws-

For the purpose of draws, software designed by Sharada Data Systems shall be used.

Draws once completed and signed can be changed by the chief referee only in the following conditions and authorizations-

1. If any seeded player withdraws his entry, then seeding committee may change the seedings to balance the draws
2. If valid entry of any seeded player is missed out, seeding committee will change the seedings.
3. If valid entries of unseeded players are missed out and they cannot be accommodated in dummy entries provided, chief referee will redraw with the consent of the seedings committee.

4. If any seeded player wishes to give late entry after the seedings are given or the draws are completed, decision regarding the same will be taken by the managing committee.

5. If any player makes a protest or complaint regarding the draws, the managing committee will take decision in the matter.

If, however, the matches of the event have started, the draws cannot be changed.

In case of any dispute, Managing Committee's decision will be final and binding.

10. PDTTA Seeding Guidelines:

- For the 1st tournament, seeding shall be given as per last year ranking list based on the final selection criteria for that year.
- There will be no change in the seeding in the 2nd tournament (apart from regular shuffling of positions)
- From the 3rd tournament onwards, the seeding shall be given based on the total points accumulated /earned by the player in that year up to that particular tournament.
- National ranked players (Top 16) OR State ranked players (Top 8) OR distinguished former player in any category may be given due consideration in the seeding.

- The shuffling shall be done as per the description of the Seeding Committee.
- While giving seeding if there is tie between 2 players, their performance in the state rankings will be considered. In case the state level performance is not available, the seedings shall be based as per the description of the Seeding Committee.
- In Doubles Event, the seeding will be given at the description of Seeding Committee.

11. Rankings guidelines

Year-end ranking shall be based on the selection criteria mentioned in Point No. 13.

In any exceptional case or any dispute, the decision of the seeding committee pertaining to seeding shall be final and binding.

- Points shall be awarded for pre quarterfinal as per points table (only when the total number of entries in that particular event are more than 24)
- State Ranking Points are allotted as grace points based on the points earned on the performance of the State Ranking.

13. The criteria for Selection of players shall be as under:

- If the number of tournaments conducted in Pune during the year is 5 or less, participation in minimum 3 District Ranking Tournaments + the District Championship and minimum 1 State Ranking Tournament shall be the compulsory criteria. If the number of tournaments conducted in Pune during the year is 6 or more, participation in minimum 4 District Ranking Tournaments + the District Championship and minimum 1 State Ranking Tournament shall be the compulsory criteria.

a. In case of National Ranked players (Top 16) AND/ OR State ranked Players (Top 4 in any events) the criteria for the year 2026-27 will be participation in: minimum one state Ranking +

minimum one District Tournament. These players will be eligible for direct selection if they complete this above-mentioned criterion (However, the players are required to inform accordingly in advance).

b. In case of State Ranked Players (Top 8) the criteria for the year 2026-27 will be: One State Ranking + Pune District Championship + Three District Ranking Tournaments.

- The decision about Selection of players in Pune District Table Tennis Team taken by Selection Committee & ratified by the Managing Committee shall be final and binding (The Points will not be the sole criteria for Selection).
- The unavailability of the player for playing the tournament for fulfilling the criteria for selection should be substantiated by the application / letter / medical certificate, whatever the case may be before the commencement of the tournament. The same should be submitted to the PDTTA office. The decision of Seeding or Selection Committee & ratified by the Management Committee will be final & binding.
- The player's position in the team, even after fulfilling all Criteria, may be reviewed if his / her misbehavior during any Tournament is reported by the Chief Referee / organizing secretary in writing to the Managing Committee of PDTTA. However, the concerned player will be given appropriate opportunity to present his/her stand orally AND / or in writing. In such case the decision will be entirely of the Managing Committee, which will be final & binding.
